1. To promote large-scale skill development, digital literacy, and entrepreneurship training for youth, women, and underserved communities in India.
2. To establish and operate training centres, innovation labs, e-learning platforms, and grassroots skilling programs in rural and urban areas.
3. To collaborate with Government bodies, CSR programs, NGOs, and private institutions to implement livelihood, education, and healthcare-related skill initiatives.
4. To empower communities through inclusive skilling, capacity building, digital literacy, and sustainable livelihood projects
5. To conduct workshops, seminars, certificate courses in technical, vocational, digital, soft, and life skills.
6. To develop and publish educational and vocational content in digital and print formats including books, guides, and audiovisual media.
7. To provide consultancy,

research, and ecosystem support for skilling, innovation, and sustainable development.

8. To promote gender equality and women empowerment by creating safe, skill-oriented spaces.
9. To support child protection, education, and nutrition programs for orphans and vulnerable children.
10. To support persons with disabilities (Divyangjan) through inclusive skilling and assistive technologies.
11. To implement projects on environmental conservation, climate action, and sustainability with community participation.
12. To provide services in mental health, counselling, and holistic well-being.
13. To carry out disaster preparedness training, relief, and rehabilitation for natural calamities and emergencies.
14. To promote legal literacy, rights awareness, and access to justice among marginalised citizens.
15. To support senior citizens through engagement, healthcare, and digital literacy.
16. To enable rural entrepreneurship via SHGs, cooperatives, and market linkages.
17. To support ethical technology innovations (AI, IoT, digital tools) aligned with India-centric challenges, subject to IT Act compliance.
18. To establish and manage educational and vocational institutions (ITI, polytechnics, training labs) subject to statutory approvals.
19. To run hostels, shelter homes, orphanages, and senior citizen homes for socially vulnerable groups.
20. To engage in animal welfare and shelters (Gaushalas) as ancillary activities linked to vocational training in agriculture and veterinary care.
21. To promote community healthcare via mobile clinics, health camps, sanitation drives,

and awareness campaigns.
22. To preserve and promote indigenous knowledge, folk art, classical music, Ayurveda, and crafts.
23. To facilitate consciousness development, value-based education, yoga, and meditation training only as part of skill/vocational development programs.
24. To incubate and support eco-entrepreneurship, sustainable farming, and zero-waste microenterprises.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

9 True accounts shall be kept of all sums of money received and expended by the company and the matters in respect of which such receipts and expenditure take place, and of the property, credits and liabilities of the company; and, subject to any reasonable restrictions as to the time and manner of inspecting the same that may be imposed in accordance with the regulations of the company for the time being in force, the accounts shall be open to the inspection of the members. Once at least in every year, the accounts of the company shall be examined, and the correctness of the balance-sheet and the income and expenditure account ascertained by one or more properly qualified auditor or auditors

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.
